13 To receive progress reports from the Clerk in respect of: -

- Remedial work to the two oak trees, one at the Orchard, the Millennium Green, and the second east of the bus shelter, north of the A170, adjacent to the Snainton/Brompton boundary. *Still trying to get a quote for the tree works.*
- Replacement of the Beech tree by a small apple/plum orchard on the Millennium Green, delayed temporarily pending the work on the Oak tree. *Now complete bar one apple tree which is proving tricky to source.*
- Land at Wydale Rise *No response from Beyond Housing.*
- Additional Footpath at the junction of Barker's Lane and the A170. The distance is c.10metres. *NYCC have advised the Council that they have not adopted this proposal, and furthermore do not consider it as a suitable solution to the need of safer pedestrian access to the A170 Pelican crossing from the Village Hall parking areas.* To consider an alternative footpath route, inside the Village Hall grounds, subject to consent from the Village Hall Committee and Trustees.
- To consider and approve, in principle, works necessary to manage the yew hedges at the war memorial that require significant pruning back. To determine a budget envelope within which the contract may be awarded for the works.

- To note the completion of the works to the eastern boundary.
- To determine a budget envelope within which the contract may be awarded for the works to first, large, circular bed in the main entrance parkland, where the extensive horizontal conifer in it requires complete removal. To consider what should replace the removed horizontal conifer.
